In consideration of permission to enter and remain on board the vessel, I agree as follows:

- 1. I understand and acknowledge that visiting aboard, moving about on or going to sea on commercial vessels such as this one may be dangerous and may involve risks which include, but are not limited to, bodily injury and death, and that not all such risks may be known or foreseeable. I hereby assume the risk of all dangerous conditions, known and unknown, on the vessel and the waters upon which she is sailed and moored. I accept the responsibility for losses or injuries to myself resulting from all such risks and dangers while visiting on the vessel. I also recognize that the vessel's schedule may change while I am aboard and may call to a different port(s) than originally indicated and/or may arrive at a different date and time than originally indicated.
- 2. I agree to take appropriate precautions for my own safety when visiting the vessel and will report to the person in charge any component, equipment or condition observed by me on the vessel which I believe to be unsafe. Furthermore, I agree to abide by the lawful orders of the vessel's Master and the vessel's designated officers.
- 3. I hereby release, waive and discharge the vessel, her master and crew, her owners, Charterers and insurers, and Alaska Tanker Company, LLC ("ATC"), its affiliates, members, directors, officers, agents and employees, acting officially or otherwise, as well as all other persons or entities owning an interest in or operating the vessel, from all liability to me and my conservators, guardians or other legal representatives, assigns, heirs and next of kin for any and all claims, demands, losses or damages on account of any injury, death or damage to property I may suffer, from any cause whatsoever, while I am on the vessel, the gangway of the vessel or the pier property adjacent to the vessel.
- 4. I also agree to indemnify and hold harmless ATC and all other persons mentioned in paragraph 3 above from any claim or demand on account of injury or damage I may suffer as a result of visiting the vessel.
- 5. I understand that this release, waiver and agreement to indemnify and hold harmless includes, but is not limited to damages caused, or alleged to be caused, in whole or in part by the negligence of ATC and the individuals listed in paragraph 3 above.
- 6. I agree that I will be subject to the ATC Drug and Alcohol Policy. I understand that this Policy prohibits the use, possession or sale of alcohol or drugs while on Company facilities or vessels and that my person and property may be subject to drug and alcohol screening and/or searches.
- 7. I have read the above Agreement of Release and Waiver of Liability and understand that by signing it I have given up substantial rights. I sign this Agreement voluntarily.
